The election to repair or replace shall be solely within the discretion of Improveit! Home Remodeling. Parts and materials may be provided by the manufacturer. WARRANTY CLAIMS: Owner may request service under this warranty by contacting Improveit! Home Remodeling at (614) 291-5400. A visual inspection by an authorized representative of Improveit! Home Remodeling may or may not be required.

What Is Not Covered: These warranties are granted by Improveit! Home Remodeling to the Owner only and only labor provided by Improveit! Home Remodeling is covered by these warranties. All warranties terminate immediately upon the transfer of home ownership. All warranties assume normal and reasonable use of Improveit! Home Remodeling's products or components. Minor color or textural variations from lot-to-lot of products are not product defects. These warranties do not cover any other damage, workmanship, or material failure including, but not limited to, damage caused by occurrences beyond the control of Improveit! Home Remodeling, such as settlement of the building, failure of the structure (including foundations and walls), use of incompatible accessories, removal, repair, or re-installation of any manufacturer products or components by other than Improveit!
